Disruptors in the space

- Shifting consumer behavior towards ecommerce has caused several new startups in the online grocery industry as well as attracted substantial funding
- The supporting grocery tech companies have also seen similar investment interest, including several large M&A
- Deal activity in grocery ecommerce and related technologies is expected to gather pace
- Key players include Inmar, BlueYonder, Ecrebo, Koupon Media, Ibotta, and GoSpotCheck among others



Ecommerce is the key disruptive force

- Legacy retailers have had to race on several fronts to compete with the newer online delivery
 platforms on the ecommerce front. Key strategies include upgrading ecommerce tech, M&A,
 developing new mobile apps with advanced analytics and AI, and better supplier integration
- In addition, grocery retailers have also implemented several in-store technology upgrades which are intended to vastly improve in-store shopping experience
- Companies have brought interesting technologies to the fore, including Real-Time Shelf Monitoring, Robots & Chatbots, Beacon and Location tracking etc. to boost product promotion and customer engagement while keeping an insight on individual shoppers



Current innovations in the food retail space

- The launch of Amazon Go, WalMartLabs, autonomous 24-hour convenience stores, and 'Tap-to-Go Cards' have disrupted the Grocery retail market by leaps and bounds
- Several other leading food retailers are also aggressively expanding their digital footprint
- Companies are on a mission to reduce the time a customer spends in-store and enhance the grocery delivery speed manifold, including the launch of delivery apps wherein personal shoppers pick and fulfill orders



Public comparables, M&A, and private placements

- Public comparables include food delivery platforms (DeliveryHero, GrubHub), food distributors (Sysco Corp, US Food), & liquidation marketplaces (Overstock.com, Liquidity Services)
- Key M&A in 2021 include ShopHero, Freshop, and BlueYonder, while major private placements for the year include Placer Labs (\$210m), Trax (\$210m), and Misfits Market (\$200m)






Quarterly M&A and Funding activity trends in Grocery Tech

Market Overview

- Ecommerce is expected to account for 21.5% of total grocery sales, worth \$250b by 2025
- The pandemic has significantly shifted consumers' shopping habits toward ecommerce. Over 43% of shoppers using online grocery in 2020 compared to 24% in 2018
- The global online grocery sector has over 6.6K+ startups, while the sector has attracted investment of over \$22.4n in 1.5K+ companies
- While M&A took a substantial hit in 2020, it has gathered pace in the first 6 months of 2021. Disclosed deal value totaled ~\$9.8bn from 16 deals vs \$4.8bn in the entire 2020 from 11 deals.
- Similarly, funding activity also slowed down in 2020 but has picked up in H1'21. Total disclosed deal values during this period were \$3.1bn, nearly 3x higher than in H1'20
- As expected, grocery ecommerce technology companies have seen the bulk of the deal activity
- Key 2021 targets include:

M&A:

- Blue Yonder-Connected Solutions (Panasonic): \$7.1bn
- Delivery Technologies-Uber: \$1.4bn

Funding:

- GoBrands (\$1.2bn), Gorillas Technologies (\$289m), Fetch Rewards (\$210m), Misfits Market (\$200m)
- With more consumers shifting to the online mode of shopping, several grocers are investing on improving their platforms and also making online order fulfillment more efficient



A number of technologies are emerging in this area, including demand-sensing technologies that will improve replenishment decisions and POS data analysis and in-store tracking to help make inventory data more robust



Grocery retailers have also implemented several in-store technology upgrades

- ✓ Real-time shelf monitoring: Al-powered visual monitoring or via field check teams, to ensure their products are properly displayed and promoted
- ✓ Store robots & chatbots: In-store robots to greet customers and/or track and move inventory & chatbots for customer service
- ✓ AR/ VR tools: Brands & retailers can design and refine in-store promotions before launching them
- ✓ Interactive Displays: Digital, interactive screens in stores to help boost customer engagement in the aisles
- ✓ Beacons & Location Tracking: Beacons, sensors, and Wi-Fi signals from phones to track shoppers throughout the store and provide grocery stores with insights on foot traffic and individual shoppers
- Merchandising Tools: Aim to improve merchandising for grocery stores and brands
- Music Management: Help businesses manage their in-store music playlists





Technologies shaping the grocery tech industry (cont'd)

- ✓ Smarter receipts: Help stores provide digital receipts and receipts with personalized rewards to shoppers in stores
- Digital labels: Lets shoppers scan products with their mobile phones to see additional product information
- ✓ Shopper feedback: Helps businesses solicit reviews and satisfaction ratings from customers at the point of sale
- Store management: Provides broad software platforms for store management, integrating features such as payment processing and inventory tracking
- In-store rewards: Gives grocery stores platforms to offer rewards and cash back to in-store shoppers
- Promotion optimization: Offers promotions planning and insights using data-driven strategies and AI, to improve profits and performance
- In-store shopper insights: Provides software platforms to help food and CPG brands monitor their performance at the granular store level
- Food waste management: Helps grocery stores and restaurants manage and reduce food waste
- ✓ Store gardens: Assist to set up local hydroponic farms near grocery stores and restaurants so businesses can sell sustainable, local produce

Walmart's strong push in its digital advertising business


Walmart aims to leverage its vast scale and physical assets to compete strongly with Amazon

- Recently Walmart revamped its retail media network, which included rebranding it to Walmart Connect, acquisition of Thunder adtech and a strategic partnership with adtech company, The Trade Desk
- The aggressive media push follows Amazon's rapid success in its emergence as a top digital advertising platform in the US

Key strategic advantages for Walmart:

- Vast trove of shopper data
- ✓ Huge network of ~5,000 stores nationwide with a weekly footfall of 150 million customers
- ✓ Over 170,000 screens to sell ad space in across all stores
- ✓ Aggressive strategy for a 10x growth in the next 5 years
- ✓ Thunder's technology would reduce the time taken from the ad's idea generation to the ad going live
- Partnership with The Trade Desk to allow real-time customization of ads based on "changing circumstances and real-time performance"

Current innovations in the food retail space

The two industry leaders are moving towards the omnichannel model from opposite sides

Amazon Go

- The launch of Amazon Go is Amazon's attempt to disrupt the grocery store industry with its new cashier-less way of shopping
 - The "Just Walk Out" campaign introduced in which customers can shop and leave, no check out required
- As per Amazon, Amazon Go is the world's most advanced shopping technology, made possible by the same types of technologies used in self-driving cars: computer vision, sensor fusion, and deep learning
 - Technology automatically detects when products are taken from, or returned to, shelves and keeps track of them in a virtual cart
 - When a customer is done shopping, they can just leave the store and Amazon charges their account for the items they've walked out with and sends them the receipt
- Has 26 open and announced store locations in Seattle, Chicago, San Francisco, and New York City, as of 2020. Reports suggest that up to 30 stores could be opened in the UK, branded as Amazon Fresh

@WalmartLabs

- @WalmartLabs acts as the company's separate innovation lab that focuses on technology-enabled shopping
- The Walmart Shopping App tailors a user's shopping experience, based on whether the user has the app open at home or inside the store
 - The app helps shoppers keep track of items they need with its mobile shopping list feature which can create lists using scanned paper receipts
- In 2014, Walmart introduced a new program called Savings
 Catcher, that allows users to scan Quick Response (QR) codes directly into the app to compare prices of products
 - Search My Store is another feature that provides turn-by-turn directions to specific items in a store
- Walmart has also released two other apps: The Walmart Grocery
 app is targeted at grocery pickup and delivery; and WalmartOne lets
 employees access schedules, paystubs, and other company

Current innovations in the food retail space (cont'd.)

Large global retailers are partnering with technology companies for major in-store upgrades

Brazil: Carrefour Brasil

- Though Carrefour operates internationally, it is the market leader in Brazil, where it operates supermarkets, hypermarkets, and convenience stores
- Carrefour Brazil is speeding up grocery delivery times in 12 cities, offering shoppers "express" delivery in about 35 minutes and "supermarkets" delivery in an hour
- Carrefour has partnered with delivery app Rappi for the service, which has personal shoppers picking and fulfilling customer orders
 - Customers can communicate with personal shoppers in real time, and can also get photos of their items in order to evaluate them and request replacements if they wish
 - With Rappi, Carrefour will also open 15 dark stores in nine cities throughout Brazil that will be built in existing supermarkets and hypermarkets
- In Brazil, Carrefour has partnered with Brazilian convenience store
 Zaitt to open Latin America's first fully autonomous, 24-hour
 convenience store that uses scan-and-go technology or radio
 frequency identification to offer a more frictionless experience
- Carrefour Brasil to acquire Grupo BIG Brasil SA for \$1.3b to strengthen its position in Brazil, in 2021





The Netherlands: Albert Heijn

- Albert Heijn is the leading food retailer in the Netherlands and also has stores in Belgium and Germany
 - Albert Heijn, which is owned by Ahold Delhaize, piloted the first tap-to-go store in 2017 and has plans for national expansion of the concept
 - Opened a 150-square foot automated mini-store on its corporate campus in Zaandam
 - To open ~100 small, unmanned shops (small supermarkets) in Belgium and Netherlands, in 2021
- In the Netherlands, Albert Heijn is on a mission to reduce the amount of time a customer spends in its AH to Go stores from an average of three minutes to 20 seconds
 - Using the AH to Go app or "Tap to go" card, customers just scan an electronic shelf tag when they pick up a product
- In conjunction with the Antea Group Nederland, Albert Heijn is trialling an augmented reality, in-store assistant, aimed to help shoppers find what they want in-store

- <u>Technology upgradation</u>: Partnerships with companies like <u>Google</u> (Google Search and Google Maps, predictive list-building, chatbots and integration of Google Pay), <u>Mirakl</u> (digital shopping), <u>BloomReach</u> (Al-based smart search), <u>Nuance</u> (virtual assistant and live chat), <u>Takeoff Technologies</u> & <u>Tortoise</u> (logistics automaton), <u>Bell and Howell</u> (pickup lockers) and <u>Cleveron</u> (automated and contactless grocery pickup kiosk)
- Expanding 'Drive Up & Go': The company's Drive Up & Go curbside pickup service, available at roughly 1,000 locations at the end of 2020, will be available at 1,600 of Albertsons ~2,300 stores by the end of 2021. In addition, Albertsons discontinued its own delivery fleet and partnered with Doordash and Instacart for fast deliveries with a view to improve internal efficiencies
- <u>Ease-of-use to drive digital:</u> Over the past year, Albertsons has focused on scaling its e-commerce services and streamlining fulfillment with a core focus on making its digital platform more efficient and easy to use. All of its technology and logistics partnerships are geared towards this end.
- Improve customer retention: Focused on growing basket size and improving the shopping experience for customers with its "just for U" and "fuel and grocery-based" loyalty programs which currently has over 16.4 million members. It plans to further leverage its customer analytics capabilities, to improve customer retention and provide targeted promotions for customers.

Key Strategic Initiatives - The Kroger Company

- <u>Expanding digital channel</u>: Despite being a <u>late entrant</u> in the direct-to-customer online channel, Kroger managed to break into the <u>Top 10 US ecommerce</u> companies in 2020, with digital sales nearly doubling over 2019. By 2023, the Company plans to further double its ecommerce sales. In Aug 2020, it <u>announced</u> the launch of its own ecommerce marketplace partnering with Mirakl.
- <u>Expanding fulfillment capabilities</u>: In May 2018, <u>Kroger partnered with UK-based online grocer Ocado</u> to build 20 automated customer fulfillment centers (CFCs) in the US over three years. Sized at ~350,000 square feet, the Ocado CFCs use automation and AI to fill online orders. Kroger plans to replicate the CFC model as they build the facilities across the US, extending its online retail reach.
- <u>Invest more in the digital platform:</u> On an overall basis, Kroger's operating and capital expenditure related to building on its digital channel has been steadily increasing. While it does not provide a detailed breakup, its capex and opex as % of total revenue were higher in 2020 as compared to 2019.- <u>10K</u> For 2021, capital expenditure in expanding the digital infrastructure are expected to be between <u>\$3.4bn to \$3.6bn</u>
- Expanding technology partnerships: Its current partnerships include <u>Mirakl</u> (digital marketplace), <u>Ocada and Nuro</u> (automated customer fulfillment centers), <u>Inmar</u> (digital coupons), <u>Microsoft</u> and <u>Everseen</u> (customer experience), <u>OneView Commerce</u> (smart POS),



- Ranked high in 'digital maturity': Despite being an in-store, customer service focused company, Publix has improved its digital platform offerings steadily. Per Incisiv's Report "Grocery Digital Maturity Benchmark, 2020" Publix was ranked the 3rd most "digitally mature" grocery company. In the previous year, Publix was ranked #46 on the list
- <u>Several technology partnerships</u>: To achieve the above, Publix has <u>partnered</u> with several leading technology companies like Infor (marketing automation), MicroStrategy Platform Analytics (analytics and BI), Kronos (workforce management), and <u>Instacart & SciptDrop</u> (fulfillment)
- <u>Focus on Private Labels:</u> On average grocery chains get about 14% of their sales from private label products. In recessions, private label sales can be as high as 17%. However, <u>Publix's brands make up ~20% of their sales</u>. This has been one of the key success factor for Publix.
